## BY- LAWS Institute for Rural Development

1) Membership: The membership of the institution shall be open to all above the age of 18 years.

### 2) Honorary Members:

Any eminent & distinguished person with an attitude to work for the welfare of the people may be elected by the majority of not less than two third of the members of the institution as an Honorary members of the Institution.

### 3) Contributors:

The contributors of the Society shall consist of followings. They shall pay the amount prescribed below per year.

(a) Patrons: Any person who contributes Rs. 1500.00 lump sum or more will be enrolled as a Patron of the society.

(b)Donors: Any person who contributes Rs. 750.00 lump sum or more will be enrolled as a Donor of the society.

(c)Sponsors: Any person who contributes Rs. 500.00 lump sum or more will be enrolled as a Sponsor of the society.

(d)Contributors: Any person who contributes at the rate of Rs. 50.00 per annum will be enrolled as a contributor to the society.

(e)Institutional sponsors: Any Institution which does not operate for profit which contributes Rs. 1000.00 per annum will be enrolled as an Institutional Sponsors of the society.

(f)Corporate sponsors: Any Corporate body contributing Rs. 2500.00 per annum will be enrolled as a corporate sponsors of the society.

4) Rules for Membership: Any person who fulfils the conditions laid down in the rule above & desire to be a member of the institution shall apply in writing to the secretary to be enrolled as a member thereof.

- a) Every such application shall be accompanied by an admission fee of Rs. 50 /- & a subscription fee for the current year or as the case may be, both of which shall be payable in advance.
- b) The admission fee shall be Rs. 50/- & the subscription fee shall be Rs.75/- per year or as per the categories mentioned or such other sum as may from time to time be fixed by the Institution.
- c) If a member's subcribtion falls in arrears for three months shall not be entitled to vote at any election or at any meeting of the Institution.
- d) The secretary of the Institution, thereupon, serve the defaulting member with a letter of demand, & if within a month of the receipt thereof, he fails to pay up all the arrears he shall cease to be a member of the Institution & his name shall thereupon, be removed from the roll of the members of the institution provided always that such member shall be eligible for re-admission, if within a fortnight of the shall be eligible for re-admission, if within a fortnight of the shall be eligible for re-admission.

his ceasing to be a member he pays up all the arrears together with the admission fee provided also that a member shall cease to be a member in case the Institution at a special – meeting passes a resolution by a majority of not less than 2/3 of the member without specifying any reason. The membership shall not be Transferable.

Management committee: The management of the society shall be vested in the managing of the society consisting of 13 members and they shall include president, wice-president, secretary treasurer and eight other members to be elected from among of the members of the institution.

6) Annual General Meeting: Election of office bearer and members of the Managing committee, The president and twelve members of the managing committee shall be elected every year before the end of the month of May each year. The out going office-bearers and the members shall be eligible for re-election.

Meeting Of Managing Committee: The managing committee shall ordinarily meet once atleast every month & shall be convened by the secretary, provided always that the president or the vice-president may also call such meeting whenever he deems it necessary so to do, provided also that in each such case seven days notice for such meeting has been given.

8) General Meeting: It shall be proper for the secretary in consultationWith the necessary todo so. Notice of the annual general meeting should be given at least 21 days before the due fixed for such meeting. Such notice shall state The Day, Hour & Place of meeting & shall be accompanied with a copy of agenda Proposed. A copy of notice shall be not as the notice beard of the society.

go Extra ordinary general meeting: On the written requisition of any Ten secretary & stating forth the & object or objects for which such meeting is desired to be held, the secretary shall within fifteen days of the receipt there of, convene an extra ordinary general meeting provided always that it shall be proper for the secretary or the president of the institution to call any Urgent meeting of the general body meeting on giving 7 days notice.

10) Ouorum: (a) At the general meeting of the institution called under rule 8 above & at an extra ordinary general meeting of the institution called under rule 10 above, fifteen members on the roll & entitled to vote, shall form a quorum for any meeting of the managing committee shall be 5 of whom atleast one member shall be a non-office bearer

(b) If the necessary quorum is not present at any meeting within 15minutes of the appointed time, the meeting shall be adjourned & no business shall be transacted there after, except the election of the president if a necessary & The fixing of the time & the

date of the adjourned meeting.

(c) If at any time during the course of the meeting, the attention of the president is drawn to the fact that the number of the member present has fallen short of the quorum required, the president after ascertaining the truth of the fact, shall forthwith dissolve the meeting but the business already transacted shall be valid.

(d) If on any occasion a meeting cannot be held for want of quorum the next meeting with the same agenda after the issue of the usual notice shall be held, irrespective of the number of the members present, provoided always that an extra-ordinary meeting of the

number of the memebers present, provoided always that an extra-ordinary meeting of the institution called at that requisition of the member under rule 11 above, shall not be called a sencond time for want of a quorum.

111 Election: The election of the society will be conducted once in 3 years

in the Annual General Body meeting.

12) Decision by vote: Subject to the aforesaid rules, all the questions brought before the Institution shall be desided by a majority of vote of the members present at the meeting.

13) Costody and withdrawal of money:

All money belongs to the institution shall be deposited in some bank to be selected by managing committee. All disbursements shall as far possible be made by cheques drawn on the said bank or banks by the treasurer & the secretary & president of the institution countersigned.

14) Powers And Duties of The Office Bearers:

(A) President: (I) The president shall preside over all the meeting of the institution. The president shall supervise the work of the office bearers & issue such directions to them in writing or otherwise he deems necessary.

(B) Vice Presidet: (II) In the absence of the president, the vice-president shall take

the chair.

(III) In the absence the both, one of the members present in the meeting shall be voted to the chair provoided always that the chairman presiding any meeting, to be president or, the vice-president or any other person shall have a casting vote in the event or an euqal division of votes on any question.

(C)Secretary:(I) The secretary shall keep correct minutes and records of the proceedings of the various meeting of the institution, issue notice for and convene the meeting whenever necessary in consultations of the president and shall exercise general

supervoision over the affaires of all meetings.

(II) He shall be the chief executive officer of the institution and the managing committee and shall carry on correspondence and transact all business on their behalf.

(III) He shall have power to appoint and dismiss servants, to sanction the periodical increaments to their salaries and decide all sundry matters of and concerning their leave, promotion etc subject to the general control of the president and approval of the

managing committee.

(IV) He shall keep maintain accounts & spend the funds of the Institution in payment of the salaries of the servants, furniture and other necessaries for the Institution & shall submit an account of the same at general meeting of the institution subject to the general control of the president & approval of the managing committee.

(D) Joint-secretary: The joint secretary shall assist the secretary in all matters with which he is entrusted but the secretary may, if he deems fit, delegate any of

his power to the joint secretary.

(E) Treasurer (I) The treasurer shall exercise control over the funds of the institution & shall be responsible for the proper investment & safe custody of the securities & funds of the institution. He shall have the power to operate on the bank accounts & deposits of the institution

(ii) He shall be responsible for the due collections of the subscriptions & the arrears &

shall counter sign all and the accounts maintained by the secretary.



15) Accounts: The society's accounts shall be audited by an approved auditor every year by the end of the official year. Every year the secretary shall arrange for the audit of the accounts of the society & present statements of the accounts & audit reports of the society.

As per section 13 of K.S.R Act 1960 accounts of the society along with the list of management will be filled with the Registrar of societies within 14 days of the annual general body meeting.

- 16) To have financial dealings subject to the provision of section 2 (15), 80G & 13 (1) (d) read with 13 (5) of the Income Tax Act 1961
- 13) Amalgamation: The amalgamation of the society will be made as per the provision under section 21 of the K.S.R Act 1960.
- 18.) Amendments: This amendment will be made as per provisions of section 9&10 of the K.S.R. Act 1960.
- 19) Working hours: The working of the office of the society shall be from 10.00 am to 6.00pm every weekday except holidays.
- 20) Accounting Year: The accounting year of the society shall be from 1st April to 31st march
- 22) Dissolution: The assets of the society shall be indivisible so that in the event of dissolution, no member shall have claim over them, but the entire amount after meeting the liabilities of the societies shall be utilized in such direction & manner as may be determined by the special meeting of the general body convened for the purpose as provided in section 22,23 of societies registration Act 1960.
